2021 PROCEDURES UNDER COVID RESTRICTIONS

- 1) You will be required to **wear a mask** while a) **interacting with MVPA staff**; b) at the **gatehouse** and **snack shack**; c) **while inside any building** on the property.
- 2) Our lane and baby pool reservations will remain in place. Due to the regulations stating that people must remain 10 ft. apart from non-family members, we feel at this time we must keep the lane reservations in place until we receive further guidance from the state or local health departments or the Governor. We will let you know once that system is live and ready.
- 3) You also need a **reservation to play tennis**. Check out the Tennis section below for details on reservations.
- 4) You will **NOT** need a reservation **to enter the park**. So, if you want to come enjoy a picnic dinner, get some fishing in, play on the playground, come on in the park like usual. Grab an open table or grassy space and enjoy.
- 5) We do ask that you **keep the tables where you find them**. We are still under spacing restrictions, so the tables need to remain spaced.
- 6) We will allow guests this year with some restrictions. See the Guest Pass section below for the full rules for guests in 2021. You will see on our calendar of events that we will have an End of School Year Party this will be for members only- no guests will be allowed in for this event. This will be one of the very few events that we have put a member only limit on.
- 7) As of now, we will **not be allowing private parties or pavilion rentals**.
- 8) We will still be required to ask you questions regarding COVID symptoms when you enter the park. The state has added a question regarding your vaccination status. Our gatekeepers are only asking the questions that we are required to ask under the guidelines. So, please be courteous to our gatekeepers and answer the questions they ask. And just as a rule, be kind to our staff, remember they are neighbors, members, our kids, and friends.
- 9) The **bathhouse** will still only be open at the front doors. We are not restricting the number who enter at a time, but some stalls will be blocked off. You **MUST wear your mask while in the bathhouse** (unless showering). Parents, please watch you children while in the bathhouse, no unnecessary showering. Please try to keep your distance in the bathhouse. If it is crowded, then just hang outside until someone leaves to keep safe spacing.
- 10) You will enter and exit the pools like last year. Enter at the gate behind the bathhouse. Exit the pools at the gates near the 25-meter diving board.
- 11) You can still bring in your own chairs around the pool. A few chairs will be placed around the deck area. There will be cleaning supplies out for you to clean off the chair before and after you use it.

The MVPA Board will be monitoring these procedures and has the right to adjust as needed in order to improve the member experience while also keeping MVPA staff and membership safe.

GUEST PASSES – <u>2021 Rules for Guests</u>- Due to the rules we must follow in the Governor's orders we will limit the number of guests and how guests can use the park to optimize maximum use for members. Here are the changes until we are no longer under capacity AND spacing regulations.

- 1) You must be 18 or older to bring in a guest. Members under 18 must be accompanied by an adult member on the account to bring in guests.
- 2) All guests will be given a wristband to be worn throughout their visit at the park.
- 3) No guests will be allowed to swim. This will remain in place as long as we have capacity and spacing restrictions.
- 4) This is not a change to our guest limit rule, but it bears reminding of the guest limit rules in our current MVPA rules. A member family is allowed 3 people per household member per month. For example, if you have 4 people in your membership (this does not include babysitters) your family can bring in 12 people in a calendar month.
- 5) If we see people abusing the above rules, we will have to pull all guest privileges.
